## APPENDIX-I

## Section-I PLAN OF EXAMINATION

two successive stages:

- (i) Civil Services (Preliminary) Examinations (Objective Type) for the selection of candidates for Main Examination; and
- (ii) Civil Services (Main) Examination (Written and Interview) for the selection of candidates for the various services and posts.
- The Preliminary Examination will consist of two papers of Objective type (multiple choice questions) and carry a maximum of section (A) of Section-II. This examination is meant to serve as a screening test only; the marks obtained in the Preliminary Examination by the candidates who are declared qualified for admission to the Main Examination will not be counted for determining their final order of merit. The number of candidates to be admitted to the Main Examination will be about twelve to thirteen times the total approximate number of vacancies to be filled in the year in the various Services and Posts. Only those candidates who are declared by the Commission to have qualified in the Preliminary Examination in the year will be eligible for admission A. Preliminary Examination to the Main Examination of that year provided they are otherwise eligible for admission to the Main Examination.
- The Main Examination will consist of a written examination and an Interview Test. The written examination will consist of 9 papers of conventional essay type in the subjects set out in sub-section (B) of Section-II. Also see Note (ii) under para I of Section-II (B).
- 4. Candidates who obtain such minimum qualifying marks in the written part of the Main Examination as may be fixed by the Commission at their discretion, shall be summoned by them for an interview/for a Personality Test vide sub-section 'C' of Section-II. However, the papers on Indian

The competitive examination comprises Languages and English will be of qualifying nature. Also see Note (ii) under para 1 of Section-II (B). The marks obtained in these papers will not be counted for ranking. The number of candidates to be summoned for interview will be about twice the number of vacancies to be filled. The interview will carry 300 marks (with no minimum qualifying marks).

400 marks in the subjects set out in sub- Marks thus obtained by the candidates in the Main Examination (written part as well as interview) would determine their final ranking. Candidates will be allotted to the various Services keeping in view their ranks in the examination and the preferences expressed by them for the various Services and Posts.

### Section-II

Scheme and subjects for the Preliminary and Main Examinations.

The Examination shall comprise two compulsory papers of 200 marks each.

- NOTE (i) Both the question papers will be of the objective type (multiple choice guestions).
- (ii) The guestion papers will be set both in Hindi and English. However, questions relating to English Language Comprehension skills of Class X level will be tested through passages from English Language only without providing Hindi translation thereof in the question paper.
- (iii) Details of the syllabi are indicated in Part A of Section III.

NOTE 4: (i) The concession admissible to blind candidates shall not be admissible to those suffering from Myopia.

- (iii) If a candidate's handwriting is not easily legible, a deduction will be made on this account from the total marks otherwise accruing to him.

- (vi) In the question papers, wherever required, SI units will be used.
- (vii) Candidates should use only international form of Indian numerals (i.e. 1,2,3,4,5,6 etc.) while answering question papers
- (viii) Candidates will be allowed the use of Scientific (Non-Programmable type) Calculators at the conventional (Essay) type examination of UPSC. Programmable type calculators will however not be allowed and the use of such calculators shall tantamount to resorting to unfair means by the candidates. # C. Interview test

The candidate will be interviewed by a Board who will have before them a record of his/her career. He/she will be asked questions on matters of general interest. The object of the interview is to assess the personal suitability of the candidate for a career in public service by a Board of competent and unbiased observers. The test is intended to judge the mental calibre of a candidate. In broad terms this is really an assessment of not only his intellectual qualities but also social traits and his interest in current affairs. Some of the

- (iv) Marks will not be allotted for mere su- qualities to be judged are mental alertness, critical powers of assimilation, clear and logical exposition, balance of judgement, variety and depth of interest, ability for social cohesion and leadership, intellectual and moral
  - The technique of the interview is not that of a strict cross-examination but of a natural, though directed and purposive conver-
  - sation which is intended to reveal the mental qualities of the candidate.
  - The interview test is not intended to be a test either of the specialised or general knowledge of the candidates which has been already tested through their written papers. Candidates are expected to have taken an intelligent interest not only in their special subjects of academic study but also in the events which are happening around them both within and outside their own state or country as well as in modern currents of thought and in new discoveries which should rouse the curiosity of well educated youth.
