- 4.2 Upper age limit is relaxable by 5 years for the candidate belonging to backward classes (**Only Maharashtra Domicile Candidate**) wherever the post is reserved for that category of backward class.
- 4.3 Upper age limit is relaxable by 5 years for the candidates (**Only Maharashtra Domicile Candidate**) applying against Sports Quota in pursuance of G.R No. Rajya Krida Dhoran-2002/No. 68/KRI.U.SE-2 dated 30.04.2005 issued by Department of School Education and Sports, Govt. of Maharashtra, subject to production of certificate showing that they do not belong to "Creamy Layer" category issued by the appropriate Competent Authority.
- 4.4 The condition of upper age limit is not applicable to the departmental employees working in the Company (only in MSETCL).
- 4.5 Date of birth as per SSC/School leaving certificate and age as on 18.07.2012 should be mentioned.

#### 5. Reservation:

- There shall be 30% horizontal reservation for women (Only Maharashtra Domicile Candidates and who do not belong to Creamy Layer category) as per the provision of Govt. of Maharashtra Resolution No. 82/2001/MSA-2000/PK 415/K-2 dt. 25.05.2001. The women candidates who desire to avail benefit of women reservation including Open category (except SC/ST) should submit latest/current year Non Creamy Layer Certificate from the appropriate Competent Authority of Govt. of Maharashtra showing that they do not belong to "Creamy Layer" category. All woman candidates availing benefit of women reservation should submit Domicile certificate of Maharashtra State issued by the appropriate Authority of Govt. of Maharashtra.
- 5.2 There shall be 5% horizontal reservation for Sports Persons of Maharashtra State as per the provision of Govt. of Maharashtra Resolution No. Rajya Krida Dhoran-2002/No. 68/KRI.U.SE-2 dated 30.04.2005 issued by Department of School Education and Sports, Govt. of Maharashtra. The candidates who desire to avail benefit of reservation for sports person should submit relevant sports certificate issued by Competent Authority as stipulated in the Govt. Resolution mentioned above. Further, as per the prevailing directives of Govt. of Maharashtra, all such candidates should submit latest/current year Non Creamy Layer Certificate showing that they do not belong to "Creamy Layer" category issued by the appropriate Competent Authority of Govt. of Maharashtra and he should submit Domicile certificate of Maharashtra State issued by the appropriate Authority of Govt. of Maharashtra.
- 5.3 The reservation policy for persons with Disability shall apply as per State Government directives. Persons suffering from not less than 40% of disability shall only be eligible for the benefit of reservation for Persons with Disability. The candidate should submit copy of Medical certificate issued by the appropriate Medical Board in terms of Govt. of India, Office Memorandum No. 36035/3/2004- Estt (Res.) dated 29.12.2005.
- 5.4 The reservation for Sports person, woman and persons with disabilities is against current reservation. The reservation for these categories i.e. Sports person, woman and persons with disabilities is Horizontal reservation and candidates selected against the quota for Sports person, woman and persons with disabilities will be placed in appropriate category viz. SC, ST, VJ (A), NT (B), NT (C), NT (D), SBC, OBC & Open categories depending upon the category to which they belong in the roster meant for reservation of the Backward classes.
- 5.5 Maharashtra State Public Services (Reservation for Schedule Castes, Schedule Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Class and Other

Backward Classes) Act.2001 has been enforced by the Govt. of Maharashtra from 29<sup>th</sup>, January, 2004. As per the provisions under Sub-section 2 (ii) of Section-4 of this Act, the principle of Creamy-Layer has been made applicable to all categories except Schedule Castes and Scheduled Tribes i.e. VJ(A), NT (B), NT(C), NT(D), SBC & OBC category. The candidates should produce **latest/current years Non-Creamy Layer Certificate** in the prescribed form issued by appropriate authority as per Govt. of Maharashtra Circular No. CBC-10/2006/PK15/BCR-5 dated 5/6/2006.

- 5.6 Candidates claiming the benefit of reservation under SC, ST, VJA, NTB, NTC, NTD, Spl.BC & OBC categories, should produce a caste certificate alongwith application. They will also enclose an attested copy of **caste validity certificate** issued by the Caste Scrutiny Committee if available with them. However, the candidate who applied without submitting Caste Validity Certificate, if selected, an appointment order will be issued to him as per the provisions / directives prescribed in G.R. of Govt. of Maharashtra vide No. बीसीसी-२०११/प्र.क.१०६४/२०१९/१६-ब दि. १२.१२.२०११.
- 5.7 For claiming the benefit of sports/caste reservation, candidates should submit attested copy of Sports Certificate, Caste Certificate, Caste Validity (If available) and Certificate of Domicile of Govt. of Maharashtra issued by the appropriate Authority of Govt. of Maharashtra.
- Those reserved category candidates who have applied as Open category & compete with the Open category candidates will be treated as Open category candidate for the purpose of recruitment/selection process. However, if any such departmental reserved category candidate who have entered in MSEB / MSETCL by taking the benefit of reservation earlier, he/she will have to submit the caste certificate & caste validity certificate from Competent Authority before appointment, if selected even though he/she may be applying under Open category against this advertisement.
- 5.9 The caste certificate issued by appropriate Competent Authority of Maharashtra State only will be considered as valid for availing the benefit of reservation including application fees.
- 5.10 The standards for the reserved category will be relaxed as per the Company's rules, if the required numbers of candidates are not available in any of the categories while short listing the candidates for personal interview and preparing the select list.
- 5.11 If sufficient number of persons with disabilities are not available on the basis of the general standard to fill all the vacancies reserved for them, candidates belonging to this category may be selected on relaxed standard to fill up the remaining vacancies reserved for them provided they are not found unfit for the post.
- 5.12 Backward class candidates should be domicile of Maharashtra State and should be of the categories notified by the Maharashtra State viz (a) Scheduled castes (including SC category person who has adopted Baudha Religion) (b) Scheduled Tribes (c) VJ-A, NT-B, NT-C, NT-D (d) Special Backward Class and (e) Other Backward Class.
- 5.13 Once the caste is notified in application form, it cannot be changed at any stage later on.
- 5.14 The Backward Class candidates who apply against Open category will not be permitted to change the option once exercised at any stage later on.

## **GENERAL CONDITIONS**

- 1) Before filling up the application form candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement.
