#### Eligibility Criteria:-I. Educational Qualification:-

S.No.1	(a)Diploma or Licentiate with not less than 60% marks in Mechanical, Electrical, Instrumentation, Electronics Engineering recognized by the Government of India, Ministry of Human Resource Development. <b>The Diploma in Engineering or Licentiate should be of three years duration after SSC</b> .  (b) Should have had English as one of the subjects either at SSC or at HSC level examination.
S.No.2	HSC(10+2) or ISC (with Science subjects) with not less than 50% marks in Science and Mathematics individually. Should have had English as one of the subjects at least at SSC level examination.
S.No.3	SSC (10years)with not less than 50% marks in Science subjects and Mathematics individually and 2 years ITI certificate in concerned discipline (For trades for which the duration of the ITI course is less than 2 years, the candidates should have at least one year relevant working experience after completion of the course).  Should have had English as one of the subjects at least at SSC level examination.

**Note**:- (A)<u>For Sl No. 1</u>-Those candidates who have passed/appeared/appearing for Degree in Engineering will not be considered and hence such candidates need not apply.

(B)<u>For Sl No. 2&3</u>:- Those candidates who have passed/appeared/appearing for Diploma in Engineering or B.Sc and equivalent degree will not be considered and hence such candidates need not apply.

#### II. Physical Standards:-

- III. <u>Upper Age Limit</u>:-The Upper age limit is relaxable for -(a) SC/ST: up to 05 years (b) OBC: up to 03 years (c) PWD: up to 05 years (For Sl No.1) and upto 10 years (For Sl No.2&3).
- IV. <u>Selection Process</u>:- The selection will be based on Written test, Trade test & personal interview in the concerned discipline.
- V. <u>Bond</u>:- The selected candidates will be required to execute a bond for serving in NPCIL for a minimum period of five (5) years after completion of training.
- VI. <u>Absorption after training</u>: On successful completion of training, the Stipendiary Trainees (Category-I) may be absorbed as Scientific Assistant/B in the PB-2 (₹.9300-34800) with grade pay of ₹.4200 and Stipendiary Trainees (Category-II) as Technician/B in the PB-2 (₹.5200-20200) with grade pay of ₹.2000.

#### **HOW TO APPLY**

- 1. The application should be submitted exactly in the proforma as given in the advertisement preferably typed on A4 size (21cm&29.5cm) paper.
- 2. The application and the outer cover should be superscribed with "APPLICATION FOR STIPENDIARY TRAINEES (CATEGORY-I OR CATEGORY-II).
- 3. Application should be accompanied with attested copies of certificates of educational qualifications with mark sheet, date of birth and SC/ST/OBC (Non-creamy layer)/PWD certificates in the prescribed format wherever applicable.
- 4. Completed application should be sent to "Post Box No. 453, Basavanagudi, Bangalore-560004" so as to reach on or before 19/03/2012. Applicants are advised to send their applications only by ordinary post and not by any other means such as Registered/ Speed Post, Private Courier service etc.

- 1. The SC/ST candidates who are not already in service of the Central/ State/ PSUs called for interview from outstation will be paid to and fro II class railway fare on production of tickets excluding 30 km in both ways in shortest route.
- 2.Persons working under Central / State Govt. / Public sector Undertakings should submit their applications through proper channel. They may however, send one advance copy of the application along with enclosures as detailed above.
- 3. Candidates appearing for final year examinations may also apply for the above traineeship. However, they are required to produce final result at the time of written test / Interview.
